# What's been happening at the ILC

Welcome to our second e-newsletter.

Since our last report we have hosted our first Student Open Forum on alcohol restrictions in Aboriginal communities which was a great success.

Also we note that a new national Indigenous representative body has been proposed. The Centre Director along with the Sex Discrimination Commissioner and Bronwyn Penrith of Mudgin-Gal issued a joint <u>press release</u> applauding the gender mandated positions for the new National Indigenous Representative Body. Megan Davis has been actively involved in advocacy for equal gender representation in a national representative body. Currently there is further research being conducted into the many barriers and obstacles that remain to Indigenous women's participation such as child care, income, capacity etc.

In other news, the Director is pleased and delighted to join the Diplomacy Training Program's Board of Directors. The Diplomacy Training Program (DTP) is an independent NGO and is responsible for running human rights programs around the region. This is the <u>DTP's 20th anniversary</u>.

The Director also recently participated as a Human Rights expert and trainer to the United Nations Institute of Training and Research (UNITAR) Regional training program to enhance the conflict prevention and peace building capacities of Indigenous peoples representatives of the Pacific in Cairns (19<sup>th</sup> to 25<sup>th</sup> August).

On the research and conference front, ILC Researcher Erin Mackay presented her research 'A Proposal for Sui Generis Legislation to Protect Indigenous Traditional Knowledge', at the 14<sup>th</sup> Biennial Copyright Law and Practice Symposium on 16 October 2009. The Centre Director has presented her research in many forums including the a seminar on the UN Declaration on the rights of Indigenous Peoples for *Reconciliation for Western Sydney* at the Migrant Resource Centre in Parramatta. Dr Kyllie Cripps presented on violence and sexual assault in Indigenous communities at the National Indigenous Legal Conference in Adelaide. Dr Cripps has been appointed to the National Health and Medical Research Council Primary and Community Health Committee and the Aboriginal Torres Strait Islander Advisory Committee. Megan Davis was also appointed to the Australian Law Reform Commission Royal Commissions Advisory Committee and the Indigenous Advisory Committee of the Australian Law Reform Commission.

Finally Megan Davis spoke at the Australian Human Rights Centre and G+T Centre of Public Law Human Rights Roundtable on Chapter 9 of the National Human Rights Consultation report expressing disappointment at its discussion of Indigenous rights. The ILC intends to run a conference in 2010 addressing the inaccuracies of the report on Indigenous rights and the incorrect notion that Indigenous specific rights have no normative basis in law.

# Fitzroy Crossing Alcohol Restrictions - Student Open Forum held on 22 September

In September, student volunteers at the ILC hosted a public forum at UNSW about alcohol restrictions in Indigenous communities. The forum presented Yajilarra, a documentary about a group of Indigenous women in Fitzroy Crossing, WA, who successfully campaigned to introduce alcohol restrictions in their town.

After the screening, a panel consisting of Maggie Brady, Liz Broderick, Cassandra Goldie, Jane Latimer, Sean Brennan and Megan Davis discussed the issues raised, as well as some broader questions about the complexity of balancing individual rights with the need for better health outcomes for Indigenous communities.
